The Florence Jones Woodwind Scholarship has been established by Derek Jones to support one student undertaking the final or Honours year studying classical flute, oboe, clarinet or bassoon in an undergraduate program of study in the Elder Conservatorium of Music at the University of Adelaide.

The scholarship shall be known as the 'Florence Jones Woodwind Scholarship'. The scholarship will be awarded annually to a student who has demonstrated outstanding achievement, commitment and potential for further advancement in the field.

This application form should be returned, together with the following documents:

1. Academic transcript
2. Outline of study plans together with purpose for which the scholarship will be used
3. Curriculum vitae (optional)

The value of this Scholarship is \$3,000 in accordance with the rules outlined on page 2-3 of this form.

Applications close on 3 April.

FLORENCE JONES WOODWIND SCHOLARSHIP SCHOLARSHIP RULES

BACKGROUND

The Florence Jones Woodwind Scholarship has been established by Derek Jones to support one student undertaking the final or Honours year studying classical flute, oboe, clarinet or bassoon in an undergraduate program of study in the Elder Conservatorium of Music at the University of Adelaide.

The following rules are hereby made:

RULES OF THE SCHOLARSHIP

1. The Scholarship shall be known as the "Florence Jones Woodwind Scholarship".
2. Recipients must be Australian citizens undertaking study as a Commonwealth supported student and must remain enrolled on a full time basis in the approved program for which the scholarship was approved.
3. The annual value of the Scholarship is \$3,000 payable in two equal instalments direct to the student following confirmation of enrolment and outstanding academic progress after each of the census dates (usually 31 March and 31 August each year).
4. One Scholarship shall be awarded annually to a student studying classical flute, oboe, clarinet or bassoon and undertaking their final or Honours year in an undergraduate program of study in the Elder Conservatorium of Music at the University of Adelaide who has demonstrated outstanding achievement, commitment and potential for further advancement in the field.
5. The scholarship will be offered from 2018 to 2022.
6. The Scholarship will provide assistance towards study at a University of Adelaide approved institution of the student's choice or approved private tuition either within Australia or overseas, or put towards the cost of a professional instrument. Applicants will be required to outline in writing to the Elder Conservatorium selection committee the purpose for which the scholarship will be used.
7. The scholarship must be taken up in the year in which it is offered; acceptance of the scholarship offer cannot be deferred. If a student declines the scholarship offer, the scholarship will be offered to the next eligible student.
8. The scholarships shall be administered by the Elder Conservatorium of the University.
9. Selection of the successful candidate will be made by the Head of Woodwind, Elder Conservatorium of Music according to demonstrated and academic merit. Academic merit for continuing students will be determined according to students' cumulative Grade Point Average (GPA) or equivalent scores.

10. Students in receipt of other University of Adelaide Scholarships may apply for this Scholarship.
11. The scholarship will be terminated where:
 - a student ceases to be enrolled in the approved program of study at the University;
 - a student has provided false or misleading information with regard to their personal details;
 - a student has failed to maintain satisfactory academic progress for two consecutive semesters;
 - a student is guilty of serious misconduct in terms of the University Policy Rules for Student Conduct in the University.
12. The rules of the Scholarship may be varied from time to time by the University in consultation with the Donor.
