

THE MARJORIE GARNER ORCHESTRAL SCHOLARSHIP FOR TROMBONE

Background -

In 1990, Herbert C. Garner donated \$8,500 to endow a scholarship for a single study student of trombone in the Elder Conservatorium, in memory of his late wife, Marjorie Garner.

In 2020, the Attorney-General for the State of South Australia approved a trust variation scheme to allow the University to offer the scholarship to a student of trombone as a principal single study, or in the absence of any such student, to a trombone student enrolled in an undergraduate music program at the Elder Conservatorium of Music.

The following Rules now apply:-

Rules

- 1. The Scholarship shall be known as the "Marjorie Garner Orchestral Scholarship for Trombone".
- 2. One Scholarship shall be awarded annually, or when a vacancy occurs due to the conclusion or termination or an existing Scholarship.
- 3. The annual value of the Scholarship is \$1,500, payable in two equal instalments direct to the student. If the student is enrolled in an undergraduate music degree, then payment will be made following confirmation of enrolment and satisfactory academic progress after each of the census dates (usually 31 March and 31 August each year).
- 4. The Scholarship shall be tenable for one year in the first instance but may be awarded to the same candidate for a maximum of three years.

Eligibility

- 5. To be considered for the Scholarship, students must be a trombone student either as a principal single study or enrolled in the Bachelor of Music or Bachelor of Music (Advanced) program of study at the Elder Conservatorium of Music.
- 6. Students in receipt of other University of Adelaide Scholarships are eligible for this Scholarship.

Selection of Candidate

- 7. The Scholarship shall be awarded to the candidate who receives the highest score for trombone in his/her audition for entry into the Single Studies scheme in each year. Should there be no trombone candidate in the Single Studies Scheme in any given year then the scholarship shall be awarded to a student enrolled in the Bachelor of Music or Bachelor of Music (Advanced) program on the recommendation of the Director of the Elder Conservatorium.
- 8. If there is no candidate of sufficient merit in any given year then the Scholarship will not be awarded in that year.

Administration

- 9. The Scholarship shall be administered by the Elder Conservatorium of Music.
- 10. The Scholarship must be taken up in the year in which it is offered; acceptance of the scholarship offer cannot be deferred. If a student declines the scholarship offer, the scholarship will be offered to the next eligible student.



- 11. The Scholarship will be terminated where:
 - a student ceases to be enrolled in the approved program of study at the University;
 - a student has provided false or misleading information with regard to their personal details;
 - a student has failed to maintain satisfactory academic progress for two consecutive semesters;
 - a student is guilty of serious misconduct in terms of the University Policy Rules for Student Conduct in the University.
- 12. The University may vary the rules from time to time in a manner consistent with the University's legal obligations and policies.
